PRESIDENT'S REPORT

The CLSA Board has been busy since the end of the summer – Kirsten Kramar, Vicepresident and program chair for 2007, and Debra Parkes, Vicepresident and secretary, have been particularly active, and I am very grateful for their constant support. The main initiatives we have been working on are as follows:

Annual meeting 2007: Preparations are already under way for the 2007 CLSA meetings, to be held in conjunction with the Congress in Saskatoon, May 31-June 2nd inclusive. Kirsten Kramar, the program chair, took part in the organizing meeting in September, together with our local arrangements coordinator, Dwight Newman (who deserves the CLSA's eternal gratitude for taking on this key task). A social gathering and dinner have already been booked at an aboriginal-run venue, and other receptions are also in the works, so there will be plenty of

opportunities for socializing with old friends and meeting new members – an essential, if not the essential, part of any successful conference! A call for papers has been issued – check CLSA website for details. And in December, look out for details on the May 31st panels cosponsored with CALT and the Law Deans (see below).

CLSA responds to the abolition of the Court Challenges program and the Law Commission of Canada. As soon as the government announced the closing of these two organizations, the CLSA decided to organize a day during the Congress that will serve not only to protest Harper's high-handed attack on legal resources, legal education and legal research in this country but also to publicize and analyze the work done by these important bodies. The Council of Law Deans and the Canadian Association of Law Teachers (CALT) are cosponsoring the events, and the Law Deans are kindly providing some sustenance (much needed since the Law Commission's always popular wine and cheese reception will obviously not be held.) The morning of May 31st will see a high-profile panel on the Court Challenges program that will be advertised throughout the Congress and should draw media and the public. Details of this panel, entitled "Whose Charter is it now?" will be announced on the CLSA website as speakers are confirmed. In the afternoon there will be one panel in which senior legal scholars will recount the history and the significance of the Law Commission, and another panel featuring some of the research left orphaned by this body's untimely abolition. Given that in the past CLSA annual meetings featured a "Law Commission Day" that worked as a catalyst for law professors and socio-legal scholars outside law schools to get to know each other and each other's work, we are very pleased to see that the joint day of events will still be held despite the Law Commission's absence. We hope that many researchers and academics previously associated with the Commission will turn up in numbers.

Graduate student activities. Rashmee Singh was elected to the CLSA board as a graduate student representative, where she joins Emma Cunliffe. On other graduate student news, the grapevine tells us that the "Audacity of Imagination" awards for graduate student research previously given by the Law Commission of Canada may be re-born under a new sponsorship.... watch the CLSA website for details.

Attention CLSA board members: mid-winter meeting, Vancouver January 18-20. Renisa Mawani and Fiona Kelly are organizing the mid-winter Board meeting at UBC, and in conjunction with it, a one-day research workshop in which Board members (and

CLSA members who are in or near Vancouver) can present their work. The research day (January 19) will be preceded by a keynote talk by socio-legal historian Tina Loo and a reception (evening of January 18). Other CLSA members are welcome to participate in the evening event, the research day and in the Board meeting; contact Renisa Mawani for details.

Looking to the future: joint LSA/CLSA meetings, Montreal 2008. As already reported to the membership in June 2006, the Law and Society Association asked CLSA to cosponsor a joint annual meeting in 2008 in Montreal, and we agreed. Plans for this event will get seriously underway in a few months, but we have already 'fingered' a few people for the program committee – a joint LSA-CLSA committee whose CLSA members are more or less bilingual and bijuridical.

Finally, thanks once more to Ruth Murbach for continuing to perform the hard work of running the association's journal, to Bruce Ryder (aka treasurer for life) for continuing to count the association's pennies, to Richard Weisman for having kindly agreed to once again take charge of the electronic newsletter – and to everyone on the board for helping when asked and, last but not least, for your support and good cheer. A board in which people get along and are always cooperative and helpful is not something to be taken for granted.

LA LETTRE DU PRÉSIDENT

Le conseil d'administration de l'Association canadienne de droit et société (ACDS) a été tenu très occupé depuis la fin de l'été. Kirsten Kramar, vice-présidente de l'Association et présidente des programmes pour 2007, et Debra Parkes, vice-présidente et secrétaire, se sont montrées particulièrement actives et je leur suis très reconnaissant de leur soutien constant. Voici les principaux projets auxquels nous avons travaillé :

Réunion annuelle de 2007: Nous avons déjà entamé les préparatifs des rencontres 2007 de l'ACDS, qui auront lieu durant le Congrès de Saskatoon, les 31 mai, 1^{er} et 2 juin. Kirsten Kramar, présidente du programme, a participé à la séance d'organisation de septembre, avec Dwight Newman, notre coordonnateur local (l'ACDS lui doit une éternelle gratitude pour avoir accepté cette responsabilité clé). Des réservations ont déjà été prises en vue d'une soirée et d'un dîner autochtones, et d'autres réceptions se préparent. Les occasions de retrouver des amis et de lier de nouvelles connaissances ne manqueront donc pas, et c'est là un élément, voire l'élément indispensable au succès de toute conférence. Une demande de

communications a été lancée – vous en trouverez les détails sur le site Web de l'ACDS. À partir de décembre y seront également affichées des précisions concernant les panels de discussion du 31 mai, coparrainés par l'Association canadienne des professeurs de droit (ACPD) et le Conseil des doyens et doyennes des facultés de droit (voir ci-dessous).

L'ACDS réagit vis-à-vis à la suppression du Programme de contestation judiciaire et de la Commission du droit du Canada. Dès que le gouvernement a annoncé l'élimination de ces deux institutions, l'ACDS a décidé de leur consacrer une des journées du Congrès afin non seulement de protester contre les attaques intempestives de M. Harper contre les ressources, l'enseignement et les études juridiques du pays mais aussi pour mieux faire connaître le travail accompli par ces importantes institutions. Le Conseil des doyens et doyennes des facultés de droit et l'Association canadienne des professeurs de droit (ACPD) co-parrainent les activités organisées ce jour-là et le Conseil des doyens et doyennes nous fait la gentillesse de se charger de la nourriture (geste d'autant plus apprécié que, de toute évidence, le populaire vins-fromages habituellement offert par la Commission du droit ne pourra pas avoir lieu). Au cours de la matinée du 31 mai se tiendra un panel de discussion sur le Programme de contestation judiciaire. Ce panel, qui réunira des personnalités de haut niveau devrait susciter beaucoup d'attention pendant toute la durée du Congrès, tant de la part des médias que du public. Plus de précisions au sujet de ce panel intitulé « Whose Charter is it now ? » - « Qui la Charte défend-elle à présent ? » seront affichées sur le site Web à mesure que nos organisateurs recevront la confirmation de participation des conférenciers invités. En après-midi, un premier panel constitué de chercheurs juridiques de haut niveau retracera l'historique et l'importance de la Commission du droit. Un second panel présentera certains des dossiers dont l'étude a dû être abandonnée du fait de la suppression intempestive de la Commission. Par le passé, le rassemblement annuel de l'ACDS comportait une journée consacrée à cet organisme qui servait de catalyseur aux rencontres entre les professeurs de droit et les chercheurs en droit et société exerçant à l'extérieur des facultés de droit et leur permettait d'échanger au sujet de leurs travaux. Nous sommes donc très heureux qu'en dépit de l'absence de la Commission du droit, ces activités puissent malgré tout avoir lieu. Nous espérons que nombre des chercheurs et universitaires qui étaient associés à la Commission se présenteront en grand nombre.

Activités du caucus des étudiants de 2e et 3e cycles. Rashmee Singh a été élue au conseil

d'administration de l'ACDS à titre de représentante des étudiants et étudiantes de 2^e et 3^e cycles, où elle vient rejoindre Emma Cunliffe. Autres nouvelles du côté étudiant, selon la rumeur, le Prix Audace de l'imagination Nathalie Des Rosiers, une bourse d'étude décernée par la Commission du droit en vue de récompenser des étudiants pour l'originalité et le caractère novateur de leurs recherches de 2^e ou 3^e cycles, pourrait bien avoir trouvé un nouveau parrainage... si cela vous intéresse, soyez à l'affût des nouvelles affichées sur le site Web de l'ACDS.

Pour les administrateurs de l'ACDS : conférence de la mi-hiver - du 18 au 20 janvier à Vancouver. Renisa Mawani et Fiona Kelly préparent actuellement la réunion du conseil d'administration de la mi-hiver, qui se tiendra à l'UBC, et la journée de travail qui aura lieu conjointement, au cours de laquelle les administrateurs de l'ACDS et les membres de l'Association qui sont à Vancouver ou dans la région pourront exposer leurs travaux. Cette journée d'études du 19 janvier débutera par un discours liminaire prononcé par Mme Tina Loo, socio-historienne. Une réception aura lieu la veille au soir, soit le 18 janvier. Tout membre de l'Association est cordialement invité à prendre part à la réception, à la journée d'études et à la réunion du conseil d'administration. Pour plus de précisions, veuillez vous renseigner auprès de Renisa Mawani.

Projet à venir : réunion conjointe de la LSA/ACDS, Montréal 2008. Ainsi que les membres de l'ACDS en ont été informés en juin 2006, la Law and Society Association (LSA) a demandé à notre association de coparrainer une assemblée annuelle conjointe à Montréal en 2008 et nous avons accepté. Il faudra travailler sérieusement à la planification de cet événement d'ici quelques mois mais nous avons déjà « repéré » quelques personnes susceptibles de faire partie du comité conjoint LSA-ACDS du programme – les représentants de l'ACDS qui en feront partie devront être suffisamment à l'aise dans les deux langues et les deux disciplines.

Meeting commenced at: 12:45

1. **Welcoming remarks and President's Report (Mariana Valverde).** Mariana introduced board members and briefly highlighted plans for the upcoming meetings in 2007 (Saskatchewan with the Congress), 2008 (Montreal as a joint conference with Canadian and American Law & Society Associations). Questions the accessibility for the 2008 conference were raised and it was decided that the board would appoint a committee for the 2008 conference at the board meeting and that accessibility would be included in their mandate
2. **Agenda and Minutes.** Approval of the agenda and 2005 AGM minutes, as amended (a few names of those in attendance had been inadvertently omitted), was moved by Kirsten Kramar and seconded by Richard Weisman. Carried.
3. **Conference Report (Jane McMillan).** Jane noted that the registration was approximately 140 people. A Baldy Center workshop on Criminal Law, Terrorism, and the State of Emergency is scheduled for **May 2007**. Organized by Markus Dubber, University at Buffalo Law School, and Lindsay Farmer, University of Glasgow School of Law, this workshop will provide a common international and interdisciplinary forum for legal doctrinal and political theoretical debates between criminal law scholars and political theorists on the position of criminal law, terrorism, and states of emergency.

2. 10th Anniversary of the UBC Centre for Feminist Legal Studies

In 1997, the Centre for Feminist Legal Studies was created at UBC's Faculty of Law. Its mandate was to build on UBC's existing strength in feminist legal studies, to strengthen co-operation in research, teaching and graduate student supervision, and to enhance the visibility of the field by forging collaborative ties with people working in this field in both university and community settings. We renovated and equipped space in which to

house the Centre, its resource library, and meeting space. The Centre is now used regularly by students, faculty and visiting scholars from Canada and around the world. We have a weekly Lecture series during term and have launched several books at our annual celebration. We have also sponsored several workshops, including an international workshop on *Theoretical and Methodological Directions in Law, Feminism, Gender and Sexuality* co-hosted with the UK Centre for Law, Gender and Sexuality in August 2006. The Centre also has supported several research projects, including the Poverty and Human Rights Project and a project on Gendering Asylum.

This year we celebrate the 10th Anniversary of the Centre! We are reviewing and assessing our activities over the past 10 years and making plans for the future, with the help of students, faculty and community partners. We will host two community events in early 2007, with the goal of strengthening the Centre's role in facilitating collaboration between feminist community groups, lawyers, academics and students at UBC Law.
